  - >20 million residents (3<sup>rd</sup> most populous state)

    - Including 5.8 million acres of wildlife management areas
  - 12,133 square miles of water
  - ~12,000 miles of fishable rivers, streams and canals
  - About 7,700 lakes (of 10+ acres), covering 3 million total acres

  - More than 575 species of wildlife
  - More than 200 native species of freshwater fish
  - More than 500 native species of saltwater fish

- Management plans required for all without an existing draft plan





### State vs. Federal Listing

### **Florida's Listing Process**

- 1. Species evaluation request
- 2. Convene Biological Review Group
- 3. Biological status review report
- 4. Listing recommendation approved by FWC Commissioners
- 5. Final rule published; status change effective

### **Federal Listing Process**

- 1. Petition to list
- 2. Substantial /not substantial finding
- 3. Review to determine if listing is warranted
- 4. Solicit opinions and public input
- 5. Final rule published; status change effective

Use the 60 Species Action Plans as a foundation to write an implementation plan that considers the needs of all imperiled species and outlines how those needs will be met.







# Florida's Imperiled Species Management Plan

- Outlines the regulatory components of implementation.



### Results


- We got bumped... and then:

### Lessons Learned – What Didn't Work

- Intensive outreach
  - Missed targets
  - Ineffective
  - Time consuming
  - Too traditional
  - Improved internal coordination

- Grandstanding
  - Common audience space
  - Inexperience facilitating
